4. Community Action Grant Presentations FY 2022-2023

Staff Report: Carmen Gil, Director of Community Engagement & Strategic Partnerships, presented the staff report and introduced two groups, Gonzales Christmas Smiles and Grupo Cultural de Gonzales, that showcased their accomplishments through the utilization of the Community Action Grant Funds.

Jose Chavez and Guillermina Flores, representing Christmas Smiles, delivered a presentation via PowerPoint, highlighting their successful organization of a Christmas party for single parents in the community. They expressed their heartfelt appreciation to all the generous donors and dedicated volunteers who contributed to the event's triumph. They shared captivating pictures of the families who attended and presented a video capturing the essence of the celebration. Guillermina spoke passionately about the significance of this event, emphasizing its importance to the community and expressing her gratitude for being a part of it.

Monica Rico, a member of the community, introduced an event that aimed to educate the community about Mexican traditions and heritage. With the hope of making it an annual affair, she presented a video clip showcasing the vibrant displays and explained the rich history behind the "Día de los Muertos" tradition. Additionally, she talked about the participation of local vendors as a way to support local businesses. Lastly, she thanked the fire department, police department, and recreation department for their collaboration.

Carmen Gil, Director of Community Engagement & Strategic Partnerships added that the Community Action Grant program has built local capacity, and community members like Jose, Monica, and Guillermina have been growing, developing, and leveraging additional funds thanks to this program. RECOMMENDATION

It is recommended that the Measure 'K' Oversight Committee:

- Receive the staff report;
- Accommodate public comment period;
- Discuss the staff report and spending priorities; and
- Adopt Resolution No. MKOC 2023-01, A Resolution of the Measure 'K' Oversight Committee for the City of Gonzales Recommending to the City Council a Prioritized List of Services and Programs to be Funded with Tax Proceeds Received from the Measure 'K' Transition and Use Tax During Fiscal Year 2023-2024, Including Funding Allocations.

BACKGROUND

In November 2014, 65 percent (65%) of Gonzales voters approved Measure 'K', enacting a one-half percent (0.5%) transactions and use tax. Included with the passage of the Measure 'K' Transaction and Use Tax was the formation of an Oversight Committee to monitor and provide advisory recommendations to the City Council regarding the use of the tax revenues. The formation of the Oversight Committee was instrumental to the passage of Measure 'K' and was necessary to maintain the public transparency needed for the use of these funds.

REVIEW & ANALYSIS

This report aims to provide the Committee with a list of potential projects/programs to fund with the Measure 'K' tax proceeds.

Exhibit 'A' is a list of proposed programs and services to be funded with the Measure 'K' Transaction and Use Tax (TUT) during Fiscal Year 2023-2024.

Revenues from Measure K have continued to increase over the years. In 2021/2022 the budget for Measure K was \$705,000, and in 2022/2023 it is \$750,000. In 2023/2024 it will be \$831,500, a 10.87% increase from last year.

Recommended FY 2023/24 Funding Priorities

Exhibit 'A' of the Resolution is a matrix that details the recommended projects and programs for FY 2023-2024. The programs are broken down as follows:

- **Group 1** are "High Priority" projects that are recommended for continued funding;
- Group 1A are Additional Project/Program recommended for FY 2023-2024

Recommended for FY 2023/24- Group 1

- 1. <u>Fund the debt service for the renovation of the Community Pool. (\$130,000)</u> On March 7, 2016, the City Council approved a financing plan for the Community Pool Improvement Project. The approved financing plan includes private placement financing of approximately \$1.5 million for a period of fifteen (15) years at an interest rate of 2.88%. The annual debt service payment is slightly less than \$130,000, which staff recommends be funded through the Transaction and Use Tax proceeds. This obligation will carry forward to cover the annual debt service until the debt service is paid off or as long as the tax is in place.
- 2. <u>Fund Youth Services/Development Activities (\$95,000)</u>, including: (a) Youth Services Development Staffing; (b) Gonzales Youth 21st Century Success Initiative (GY21CSI), including: Kinder readiness, 3rd grade reading and writing proficiency, and 8th grade math proficiency, and incorporates the Gonzales Youth Council. The City Council continues to consider the funding of services for youth programs and development to be of high priority.

<u>After School 'Kid-Power' Program (\$90,000).</u> In 2017 the City of Gonzales, created Kid Power to complement the Gonzales Unified School District after-school program known as A.S.E.S (After School Education and Safety Program). The 'Kid-Power' program now stands independent of A.S.E.S and has become a staple in the community. The program provides recreational enrichment, homework, and other educational assistance and programming. In line with the City's youth initiative, the funding has allowed the City to provide additional resources, activities and programs for youth.

Gonzales Day Camp (\$75,000): The City's Recreation Department's Summer Day Camp has been a community favorite since its inception in 2016. As proposed, the day camp will continue to provide the means for parents, and families to have reliable day care for their children for the entire 7 weeks that school is not in-session during the summer months. As envisioned, the program will have a 1 to 12 adult-to-child ratio with 1 Summer Camp Intern for each group of children. Children are grouped by ages to keep activities age appropriate and always supervised by trained staff.

Summer Day Camp will include daily swimming, environmental education, STEM activities, character education, service learning, arts and crafts, group games, daily reading activities, walking trips to parks and the library, participation in popular City activities such as Fun in the Garden, and the Kid's Safety Academy, and City-sponsored learning activities.

To keep the cost affordable for families, and maintain and expand the program¹, the proposed budget and recommended Measure 'K' funds allocation is \$60,000, which will be used to offset the cost of staff for the program which sees 100-225 participants. With the cost of staff offset, the price is approximately \$100 per week. Because the program will be funded with City of Gonzales tax monies, the reduced rate program will continue to be limited to those who can show proof that at least one parent or guardian either lives or works in Gonzales. The benefit of this funding cannot be understated because it allows the program to be provided for \$100 a week to Gonzales residents for an enriched recreational and educational experience. Continuing funding for this activity will help the City meet its Youth Development goals by providing jobs and internship opportunities to more youth; meeting the needs of working families for reliable and consistent childcare; prevent "summer slide" in education; allowing more space in the Summer School program for youth who truly need academic assistance; expose the youth participants to all of the wonderful programs the City has developed; create an open environment for youth to use hands on learning in areas that they might not otherwise be exposed to; provide opportunity to participate in service learning projects to help the community; and most of all, build lifelong relationships with staff and interns as positive role models.

- 3. <u>Community Participation Grants (\$30,000)</u>: This program has been very successful and has become a staple in the community. This funding allows local community groups, and advocates to perform a service for the community through various unique community activities (e.g., Senior Services, Adult Learning, Child Services, Educational Advancement, Quality of Life and Economic Development).
- 4. <u>Police Department, Community Policing (\$5,000):</u> The police department utilizes these funds to provide community policing efforts that allow them to engage with the community weather that is through trading cards, outreach materials and/or events such as National Night Out where they can interact with the public in a positive manner.
- 5. <u>Senior Programming (\$25,000)</u>: City staff seeks to support more senior and adult programming through services that support increased physical activity and engagement and prevention.
- 6. <u>Olinga "Wings of Knowledge" Youth STEM program (\$20,000):</u> Setting aside funds for this program would assure the continuation of STEM programming available to Gonzales Youth. This STEM program has resulted in our youth constructing water sensors in partnership with local farmers and a weather station in partnership with the National Oceanic and Atmospheric Administration (NOAA) that has been placed into production and is supplying data into the NOAA weather prediction algorithms that leads directly to improving the local forecast.
- 7. <u>Salinas Valley Promise Scholarship Program (\$15,000)</u>: This program began in FY19/20 and is a partnership with Hartnell College. This program is heavily focused on keeping young students in college during the most critical first two years. The impact of this programming cannot be overstated in that in the academic year 2019-2020 it saw approximately half (55) of our graduating seniors move into higher education and enroll in Hartnell. With the impact of the pandemic academic year 2021-2022 saw a slight increase in the number of students which continued into year 2022-2023.

Recommended for FY 2023/24- Group 1A

- 8. <u>Aquatics Programming (\$76,000)</u>: This funding allows the City to continue to provide aquatics programming to the entire community. The current pool fees do not offset the total costs of the pool repairs and staffing. These funds would allow us to continue providing an adequate level of service and the staffing needed to run the facility.
- 9. Three new full-time Fire Fighter positions to Augment Services (\$250,000): The Gonzales Fire Department has a long and rich history of utilizing volunteers to cover the community, however, with the increase in large fires that annually appear to plague the State, Cal Fire is keeping their temporary/seasonal positions longer, which has made it very difficult for departments to maintain the number of volunteers needed. With the support of the TUT Measure K Committee, 3 eightmonth seasonal Fire Fighter positions were approved and added to the budget in FY 2021-2022; however, because Fire Fighters are in such high demand it is difficult to retain them here on a seasonal basis, therefore keeping them on fulltime status makes more sense for the City in order to maintain the coverage necessary for our community.
- 10. <u>City Sports Programming (\$20,500)</u>: Our City Sports leagues continue to grow each year, not only are there more participants in our programs but we have made more sports available to the public. There is also added interest in other sports leagues that we are attempting to start up with other cities. These funds allow us to continue to provide a verity of healthy activities and options for our residents.

A RESOLUTION OF THE MEASURE 'K' OVERSIGHT COMMITTEE FOR THE CITY OF GONZALES RECOMMENDING TO THE CITY COUNCIL A PRIORITIZED LIST OF SERVICES AND PROGRAMS TO BE FUNDED WITH TAX PROCEEDS RECEIVED FROM THE MEASURE 'K' TRANSITION AND USE TAX, DURING FISCAL YEAR 2023/2024, INCLUDING FUNDING ALLOCATIONS

WHEREAS, on November 4, 2014, 65 percent (65%) of Gonzales voters approved Measure 'K', enacting a one-half percent (0.5%) transactions and use tax; and

WHEREAS, included with the passage of the Measure 'K' Transaction and Use Tax, was the formation of an Oversight Committee to monitor and provide advisory recommendations to the City Council with regard to the use of the tax revenues; and

WHEREAS, formation of the Oversight Committee was instrumental to the passage of Measure 'K', and necessary to maintain the public transparency needed for the use of these funds; and

WHEREAS, the MKOC meeting of June 15, 2020, was properly noticed; and

WHEREAS, on November 3rd, 2020, the voters extended term of the City's TUT, set to expire in 2024, through 2044; and

WHEREAS, on May 23rd, 2023, the Oversight Committee met and reviewed and discussed a list of possible services and programs to fund with tax proceeds, and premised on the City's Mission and Vision Statements; and

WHEREAS, after consideration of all pertinent testimony, the information contained in the staff report, comments from the public, and the comments and discussion of its members, the Oversight Committee has the pertinent information necessary to formulate a recommendation for a list of funding priorities and funding allocation for the use of Measure 'K' tax proceeds to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the Measure 'K' Oversight Committee for the City of Gonzales, as follows:

Section 1. The foregoing recitals are true and correct and are a substantive part of this Resolution.

<u>Section 2</u>. The Oversight Committee recommends the prioritized list of recommended services and programs identified in the attached Exhibit 'A' for funding with tax proceeds from the Measure 'K' Transaction and Use Tax to the City Council, including funding allocations.
