## NOTICE OF JOINT WORKSHOP FOR NEW HOUSING COMING TO GONZALES

**NOTICE IS HEREBY GIVEN** that the Planning Commission and City Council of the City of Gonzales will conduct a <u>Joint Workshop on Tuesday</u>, <u>November 12th</u>, <u>2024</u>, <u>beginning at 5:30 pm in the City Council Chambers</u>, <u>117 Fourth Street</u>, <u>Gonzales</u>, <u>California</u>, to consider the items referenced below.

- The Vista Lucia Specific Plan Annexation and Tentative Map Project A proposal for the future development of up to 3,498 residential units, comprised of single-family and multi-family residential units, along with two commercial/residential mixed-use centers totaling 8 acres in size, proposed elementary school sites, a middle school site, and 79 acres of recreational facilities. Development of the proposed project would occur over multiple phases, depending on market demand and the ability to provide necessary infrastructure. The initial proposed phase includes a **Tentative Subdivision Map** and a Phased Annexation of 796 Building Lots accommodating up to 1,247 Units and 49 Common Lots on a Project Site of 236.5± acres Located East of Fanoe Road (Monterey County Assessor Parcel No. 223-031-027 & 024).
