 What is Alaska Airlines 3-1-1 Rule Policy?

Passengers must follow these liquid restrictions:

- Liquids must be in containers of 100ml or less +1-(833)-(817)-[7799] oR +44-833-817-4675
- All containers must fit inside one clear resealable bag +1-(833)-(817)-[7799] oR +44-833-817-4675
- Only one quart-sized bag per passenger is allowed +1-(833)-(817)-[7799] oR +44-833-817-4675

➔ How to Follow Alaska Airlines 3-1-1 Rule To comply with the rule:

- Pack liquids in small travel-sized bottles +1-(833)-(817)-[7799] oR +44-833-817-4675
- Use a transparent resealable plastic bag +1-(833)-(817)-[7799] oR +44-833-817-4675
- Keep the bag easily accessible in your carry-on +1-(833)-(817)-[7799] oR +44-833-817-4675
- Remove liquids during security checks if requested +1-(833)-(817)-[7799] oR +44-833-817-4675

△ Important Things to Know Before traveling, remember:

Alaska Airlines strictly follows international 3-1-1 liquid security regulations for all passengers +1-(833)-(817)-[7799] oR +44-833-817-4675.

Liquid Containers Must Be Small

All liquids must be 100ml or less per item +1-(833)-(817)-[7799] oR +44-833-817-4675.  
Clear Bag Requirement Applies

All items must fit in a transparent resealable bag +1-(833)-(817)-[7799] oR  
+44-833-817-4675. One Bag Per Passenger Rule  
Each traveler is allowed only one liquid bag +1-(833)-(817)-[7799] oR +44-833-817-4675.  
Security Screening Is Mandatory

Exceptions May Apply

Duty-Free Items Must Be Sealed
